Procedure,² Nevada Power Company, on behalf of NV Energy, filed a petition for declaratory order (petition) finding that Saguaro Power Company has failed to demonstrate current compliance with the operating and efficiency criteria for qualifying co-generation facilities set forth in 18 CFR 292.205(a)(2017), all as more fully explained in the petition.

Any person desiring to intervene or to protest in this proceeding must file in accordance with Rules 211 and 214 of the Commission's Rules of Practice and Procedure (18 CFR 385.211 and 385.214) on or before 5:00 p.m. Eastern time on the specified comment date. Protests will be considered by the Commission in determining the appropriate action to be taken, but will not serve to make protestants parties to the proceeding. Any person wishing to become a party must file a notice of intervention or motion to intervene, as appropriate. Such notices, motions, or protests must be filed on or before the comment date. Anyone filing a motion to intervene or protest must serve a copy of that document on the Petitioner.

Qualifying Conduit Hydropower Facility Description: The proposed

project would consist of: (1) Five 15-kW Turgo turbine units with a total installed capacity of 75 kW located at the McClellan Wash Drop of the Central Main Canal; and (2) appurtenant facilities. The proposed project would have an estimated annual generating capacity of about 900,000 kilowatthours.

A qualifying conduit hydropower facility is one that is determined or deemed to meet all of the criteria shown in the table below.

Preliminary Determination: The proposed addition of the hydroelectric project along the existing irrigation canal will not alter its primary purpose. Therefore, based upon the above information and criteria, Commission staff preliminarily determines that the proposal satisfies the requirements for a qualifying conduit hydropower facility, which is not required to be licensed or exempted from licensing.

Comments and Motions to Intervene: Deadline for filing comments contesting whether the facility meets the qualifying criteria is 45 days from the issuance date of this notice.

Deadline for filing motions to intervene is 30 days from the issuance date of this notice.

Anyone may submit comments or a motion to intervene in accordance with the requirements of Rules of Practice and Procedure, 18 CFR 385.210 and 385.214. Any motions to intervene must be received on or before the specified deadline date for the particular proceeding.
