

ACTION: Notice of information collection; request for comment.

SUMMARY: The Corporation for National and Community Service, operating as AmeriCorps, has submitted a public information collection request (ICR) entitled AmeriCorps Member Application, Enrollment, and Exit Forms for review and approval in accordance with the Paperwork Reduction Act.

The comment period ended February 28, 2025; no public comments were received from that notice. AmeriCorps reached out to several individuals for their input and made minor edits to the forms in response.

Abstract: This collection of information includes AmeriCorps’ member application, enrollment, and exit forms. The application form is used by applicants interested in serving as AmeriCorps members. The enrollment form is used by AmeriCorps members to enroll in the National Service Trust to earn Eli Segal Education Awards. The exit form is used to document the completion of a member’s term of service with AmeriCorps. AmeriCorps seeks to revise the exit form to add options for granting AmeriCorps permission to share the outgoing member’s name and email address with other Federal partners to help the outgoing member stay engaged in service. AmeriCorps also seeks to continue using the currently approved information collection until the revised information collection is approved by OMB. The currently approved information collection is due to expire on April 30, 2025.

Notice of Intent for Naval Air Station Pensacola Land Exchange

AGENCY: Department of the Navy (DoN), Department of Defense (DoD).

ACTION: Notice.

SUMMARY: This notice provides information on the proposed conveyance of approximately 5.2 acres of underutilized land at Naval Air Station (NAS) Pensacola, Special Area Bronson Field, Florida, to Escambia County, a political subdivision of the State of Florida, in exchange for a restrictive easement over approximately 31.15 acres of Escambia County owned land within portions of NAS Pensacola’s Accident Potential Zones 1 and 2, which will limit encroachment and constraints on military training, testing, and operations.

DATES: Written objection must be filed no later than May 1, 2025.

SUPPLEMENTARY INFORMATION: Pursuant to the authority of 10 U.S.C. 2684a, the United States of America and its assigns, acting by and through the Department of the Navy, and Escambia County, a political subdivision of the State of Florida, entered into a Multi-Year Agreement (MYA) to acquire long-term real property interests in the vicinity of NAS Pensacola, Florida. The purpose of the MYA is the identification and acquisition of long-term, real property interests to achieve conservation objectives, prevent encroachment and limit incompatible development in the vicinity of NAS Pensacola, including all Navy owned facilities located within the legal jurisdiction of Escambia County, Florida.

10 U.S.C. 2869 provides authority for the Department of the Navy to convey real property to carry out a land acquisition, including the acquisition of all right, title, and interest or a lesser interest in real property, *i.e.* a restrictive easement, under an agreement entered into under section 10 U.S.C. 2684a to limit encroachments and constraints on military training, testing, and operations. The Navy intends to convey approximately 5.2 acres of underutilized Navy owned property, Tax Parcel ID# 27–2S–31–2202–000–000, to Escambia County in exchange for a restrictive easement interest over approximately 31.15 acres of Escambia County owned property, Tax Parcel ID# 19–3S–31–1400–000–000, located within Accident Potential Zones 1 and 2 of NAS Pensacola, Florida. The Department of the Navy will convey the approximately 5.2 acres to Escambia County via Quitclaim Deed. Escambia County will convey the restrictive easement interest over the approximately 31.15 acres via a restrictive easement, which will limit the type and amount of development, as well as the activities that may be conducted on the land. Both the Quitclaim Deed and the Restrictive Easement will be recorded in the Public Records of Escambia County, Florida.

Abstract: The purpose of Client Assistance Program (CAP) is to advise and inform applicants and individuals eligible for services and benefits available under the Rehabilitation Act of 1973 (Rehabilitation Act), as amended by the Workforce Innovation and Opportunity Act (WIOA), and title I of the Americans with Disabilities Act of 1990 (ADA), including students with disabilities under section 113 and individuals with disabilities employed at subminimum wage under section 511 of the Rehabilitation Act. In addition, applicants and eligible individuals may be provided advocacy and representation to ensure their rights in their relationship with projects, programs, and services to protect their rights provided under the Rehabilitation Act. In addition to providing assistance and advocacy under the Rehabilitation Act, a CAP agency may provide information on the assistance and benefits on title I of the ADA, especially

those who have traditionally been unserved or underserved by the vocational rehabilitation program, with respect to services that are directly related to facilitating the employment for applicants or eligible individuals.
