In accordance with the National Environmental Policy Act of 1969 and the Federal Energy Regulatory Commission's (Commission) regulations, 18 CFR part 380, the Office of Energy Projects has reviewed the application for a new major license to continue to operate and maintain the St. Cloud Hydroelectric Project No. 4108 (project). The project is located on the Mississippi River, in the City of St.

Cloud, in Stearns, Benton, and Sherburne Counties, Minnesota. Commission staff has prepared an Environmental Assessment (EA) for the project.¹

The EA contains staff's analysis of the potential environmental impacts of the project and concludes that licensing the project, with appropriate environmental protective measures, would not constitute a major federal action that would significantly affect the quality of the human environment.
