The Commission considers all comments received about the project in determining the appropriate action to be taken. However, the filing of a comment alone will not serve to make the filer a party to the proceeding. To become a party, you must intervene in the proceeding. For instructions on how to intervene, see below.

Interventions

Any person, which includes individuals, organizations, businesses, municipalities, and other entities,⁶ has the option to file a motion to intervene in this proceeding. Only intervenors have the right to request rehearing of Commission orders issued in this proceeding and to subsequently challenge the Commission's orders in the U.S. Circuit Courts of Appeal.

To intervene, you must submit a motion to intervene to the Commission in accordance with Rule 214 of the Commission's Rules of Practice and Procedure⁷ and the regulations under the NGA⁸ by the intervention deadline for the project, which is 5:00 p.m. Eastern Time on July 6, 2026. As described further in Rule 214, your motion to intervene must state, to the extent known, your position regarding the proceeding, as well as your interest in the proceeding. For an individual, this could include your status as a landowner, ratepayer, resident of an impacted community, or recreationist. You do not need to have property directly impacted by the project in order to intervene. There are two ways to submit your motion to intervene. In both instances, please reference the Project docket number CP26–536–000 in your submission.

(1) You may file your motion to intervene by using the Commission's eFiling feature, which is located on the Commission's website (www.ferc.gov) under the link to Documents and Filings. New eFiling users must first create an account by clicking on "eRegister." You will be asked to select the type of filing you are making; first select "General" and then select "Intervention." The eFiling feature

Any subsequent submissions by an intervenor must be served on the applicant and all other parties to the proceeding. All timely, unopposed⁹ motions to intervene are automatically granted by operation of Rule 214(c)(1).¹⁰ Motions to intervene that are filed after the intervention deadline are untimely, and may be denied. Any late-filed motion to intervene must show good cause for being late and must explain why the time limitation should be waived and provide justification by reference to factors set forth in Rule 214(d) of the Commission's Rules and Regulations.¹¹ A person obtaining party status will be placed on the service list maintained by the Secretary of the Commission and will receive copies (paper or electronic) of all documents filed by the applicant and by all other parties.

Texas Eastern Transmission, L.P.; Notice of Revised Schedule for Environmental Review of the Line 31 Expansion Project

This notice identifies the Federal Energy Regulatory Commission staff's revised schedule for the completion of the environmental assessment (EA) for Texas Eastern Transmission, L.P.'s (Texas Eastern) Line 31 Expansion Project.¹ The first notice of schedule, issued on April 6, 2026, identified June 15, 2026 as the EA issuance date. However, following a series of staff data requests, and filings dated March 12, 2026 and May 11, 2026, Texas Eastern anticipates filing a response regarding the project's operational emissions by June 30, 2026. Staff will require additional time to incorporate the pending information into the EA and to determine if we can reach a finding of no significant impact in the EA. As a result, staff has revised the schedule for issuance of the EA. The issuance date is also contingent on the quality of information provided by Texas Eastern. The EA will be issued for a 30-day comment period.

Schedule for Environmental Review

Issuance of the EA: July 24, 2026.
*90-day Federal Authorization
Decision Deadline:*² October 22, 2026.

If a schedule change becomes necessary, an additional notice will be provided so that the relevant agencies are kept informed of the project's progress.
