On June 18, 2026, the Commission issued an order in Docket No. EL26-71-000 pursuant to section 206 of the Federal Power Act (FPA), 16 U.S.C. 824e, instituting an investigation to determine whether California Independent System Operator Corporation's Open Access Transmission Tariff and/or the Transmission Owner Tariffs of the Participating Transmission Owners are unjust, unreasonable, unduly discriminatory or preferential, or otherwise unlawful. *Cal. Indep. Sys. Operator Corp.*, 195 FERC ¶ 61,214 (2026).
