If the project is subject to section 15 of the FPA, notice is hereby given that an annual license for Project No. 9650 is issued to Factory Falls, Inc. for a period effective July 1, 2026, through June 30, 2027, or until the issuance of a new license for the project or other disposition under the FPA, whichever comes first.
