Foreign-Trade Zone (FTZ) 176, Notification of Proposed Production Activity; Coilcraft, Inc.; (Ferrous Iron Pre-Fabrication Material); Princeton, Illinois

Coilcraft, Inc. submitted a notification of proposed production activity to the FTZ Board (the Board) for its facility in Princeton, Illinois, within FTZ 176. The notification conforming to the requirements of the Board’s regulations (15 CFR 400.22) was received on August 11, 2026.
Pursuant to 15 CFR 400.14(b), FTZ production activity would be limited to the specific foreign-status material(s)/ component(s) and specific finished product(s) described in the submitted notification (summarized below) and subsequently authorized by the Board. The benefits that may stem from conducting production activity under FTZ procedures are explained in the background section of the Board’s website—accessible via www.trade.gov/ftz.
The proposed finished product is ferrous iron pre-fabrication material (duty free).
The proposed foreign-status material/ component is ferrous iron raw materials (duty free).
The request indicates that certain materials/components are subject to duties under section 301 of the Trade Act of 1974 (section 301), depending on the country of origin. The applicable section 301 decisions require subject merchandise to be admitted to FTZs in privileged foreign status (19 CFR 146.41).
Public comment is invited from interested parties. Submissions shall be addressed to the Board’s Executive Secretary and sent to: ftz@trade.gov. The

closing period for their receipt is September 28, 2026.

Aluminum Extrusions From the People’s Republic of China: Final Results of Antidumping Duty Administrative Review; 2024–2025

AGENCY: Enforcement and Compliance, International Trade Administration, Department of Commerce.
SUMMARY: The U.S. Department of Commerce (Commerce) determines that the 18 companies under review of the antidumping duty (AD) order on aluminum extrusions from the People’s Republic of China (China), covering the period of review (POR) May 1, 2024, through April 30, 2025, are not eligible to receive a separate rate and are, therefore, part of the China-wide entity.

Background

On April 14, 2026, Commerce published the *Preliminary Results* of this administrative review in the **Federal Register** and invited interested parties to comment.¹ On June 5, 2026, Commerce notified U.S. Customs and
